4. PRE-PRESS: All materials and/or programming used in connection with production remain the property of United Systems of Arkansas. All programming, interfacing, paste-up, copyright, instructions, and reproduction proofs produced by United Systems of Arkansas remain the property of United Systems of Arkansas.
5. PROPOSALS and DATA: Proposals are only for work according to the original specifications. Upon receipt of original computer data or manuscript, should it be evident that the condition of the data or materials differs from that originally described and consequently quoted, the original proposal shall be rendered void and a new proposal issued. 15. DISPUTES: All disputes will be resolved by arbitration. A mutually acceptable location will be chosen for the arbitration if such a


